FRESNEDI TO ENTER INTO A CONTRACT WITH MDL RESORT CONSTRUCTORS, INC., FOR THE PROJECT CONSTRUCTION OF TWO STOREY SIX CLASSROOM BUILDING PHASE 1 AT F. DE MESA ELEMENTARY SCHOOL, PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION SEVEN HUNDRED EIGHTY THOUSAND PESOS (P2,780,000.00).

WHEREAS, the proposed Construction of Two Storey Six Classroom Building Phase 1, located at *F. De Mesa Elementary School Putatan, Muntinlupa City*, chargeable against Capital Outlay – Infrastructure Projects – under the 1999 Executive Budget, is one of the priority projects of the City Government;

WHEREAS, per *Bill of Materials* the cost of the project is Three Million One Hundred Fifty Seven Thousand Nine Hundred Forty Six and Fifty Two Centavos (P3,157,946.52);

WHEREAS, per certificate and Request for Obligation and Allotment No. 221-9911-074, amounting to Three Million One Hundred Fifty Seven Thousand Nine Hundred Forty Six and Fifty Two Centavos (P3,157,946.52) is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per Resolution No. 99-15 of the PBAC, the project was awarded to MDL Resort Construction because it won the *Public Bidding* held on November 17, 1999 with the lowest price of Two Million Seven Hundred Eighty Thousand Pesos (P2,780,000.00);

WHEREAS, the Approved Agency Estimate (AAE) for the project is Three Million One Hundred Fifty Seven Thousand Nine Hundred Forty Six and Fifty Two Centavos (P3,157,946.52) and the Allowable Government Estimate (AGE) is Three Million One Hundred Four Thousand Seventy One Pesos and 52/100 (P3,104,071.52) respectively;
