WHEREAS, per certificate and Request for Obligation and Allotment No. 1019911-0548, amounting to Three Million Five Hundred Thousand Pesos (P3,500,000.00) is allocated for the project from the Infrastructure Projects under 1999 Executive Budget;

WHEREAS, per Resolution No. 99-17 of the PBAC, the project was awarded to VF. Labao Construction because it won the Public Bidding held on November 17, 1999 with the lowest price of Two Million, Six Hundred thirty Six Pesos and 80/100 (P2,000,636.80);

WHEREAS, the Approved Agency Estimate (AAE) for the project is Three Million Two Hundred One Thousand Four Hundred Eighty Two and 82/100 (P3,201,482.84) and the Allowable Government Estimate (AGE) is Two Million Eight Hundred Forty Five Thousand Six Hundred Ninety Four Pesos and 27/100) respectively;
