RESOLUTION NO. 12-234

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH V.F. LABAO CONSTRUCTION FOR CONCRETE REBLOCKING ALONG DON JESUS BOULEVARD LOCATED AT ALABANG HILLS BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF THREE MILLION NINE HUNDRED SEVEN THOUSAND NINE HUNDRED TWENTY EIGHT PESOS AND 54/100 (PHP3,907,928.54) WHICH AMOUNT SHALL BE TAKEN FROM THE 2012 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, on July 2, 2012, the 6th Sangguniang Panlungsod approved ***Ordinance No. 12-0074***, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the ***Construction Agreement*** for ratification;

WHEREAS, the concrete reblocking along Don Jesus Boulevard located at Alabang Hills, Barangay Cupang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on August 9, 2012, the City Government of Muntinlupa entered into Construction Agreement with ***V.F. LABAO Construction*** for the

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to V.F. LABAO Construction as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on **June 22, 2012**, the Bids and Awards Committee (BAC) approved **Resolution No. 12-0034**, "declaring the V.F. LABAO Construction as the bidder with the Lowest Calculated Responsive Bid for the concrete reblocking along Don Jesus Boulevard located at Alabang Hills, Barangay Cupang, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the **Supreme Court** (SC) decision, there is a need for the Sangguniang Panlungsod *to ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **V.F. Labao Construction** for concrete reblocking along Don Jesus Boulevard located at Alabang Hills, Barangay Cupang, Muntinlupa City, in the amount of **Three Million Nine Hundred Seven Thousand Nine Hundred Twenty Eight Pesos and 54/100 (PHP3,907,928.54)** which amount shall be taken under the 20% Community Development Fund (CDF) - 2012 Executive Budget.

Approved, by the 6th **Sangguniang Panlungsod of Muntinlupa** this 3rd day of **December, 2012**, on its **101 Regular Session**.
