A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH V.F. LABAO CONSTRUCTION FOR DRAINAGE CONSTRUCTION LOCATED AT DE MESA COMPOUND, BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION SIX HUNDRED SIX THOUSAND TWO HUNDRED SIXTY ONE PESOS AND 78/100 (PHP1,606,261.78) WHICH AMOUNT SHALL BE TAKEN FROM THE 2012 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, on July 2, 2012, the 6th Sangguniang Panlungsod approved **Ordinance No. 12-088**, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the drainage construction located at De Mesa Compound, Barangay Alabang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on August 14, 2012, the City Government of Muntinlupa entered into Construction Agreement with V.F. LABAO Construction for the drainage construction amounting to One Million Six Hundred Six Thousand Two

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to V.F. LABAO Construction as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on **August 6, 2012**, the Bids and Awards Committee (BAC) approved **Resolution No. 12-0068**, "declaring the V.F. LABAO Construction as the bidder with the Lowest Calculated Responsive Bid for the drainage construction located at De Mesa Compound, Barangay Alabang, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the **Supreme Court** (SC) decision, there is a need for the Sangguniang Panlungsod *to ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod, to ratify the Construction Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **V.F. Labao Construction** for drainage construction located at De Mesa Compound, Barangay Alabang, Muntinlupa City, in the amount of **One Million Six Hundred Six Thousand Two Hundred Sixty One Pesos and 78/100 (Php1,606,261.78)** which amount shall be taken under the 20% Community Development Fund (CDF) - 2012 Executive Budget.
