RESOLUTION NO. 12-237

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AM-FM BUILDERS FOR THE PROJECT STREET LIGHTING LOCATED AT MAIN ROAD, INTERCITY HOMES, BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF SEVEN HUNDRED EIGHTY THOUSAND FIVE HUNDRED FIFTY TWO PESOS AND 04/100 (PHP780,552.04) WHICH AMOUNT SHALL BE TAKEN FROM THE 2012 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, on July 2, 2012, the 6th Sangguniang Panlungsod approved ***Ordinance No. 12-080***, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the ***Construction Agreement*** for ratification;

WHEREAS, the ***STREET LIGHTING*** located at Main Road, Intercity Homes, Barangay Cupang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on July 3, 2012, the City Government of Muntinlupa entered into Construction Agreement with AM-FM Builders for the street lighting amounting to Seven Hundred Eighty Thousand Five Hundred Fifty Two Pesos and 04/100 (Php780,552.04) as a result of a public bidding held on ***June 21, 2012***;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to AM-FM BUILDERS as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on **June 22, 2012**, the Bids and Awards Committee (BAC) approved **Resolution No. 12-0039**, "declaring the AM-FM BUILDERS as the bidder with the Lowest Calculated Responsive Bid for the street lighting located at Main Road, Intercity Homes, Barangay Cupang, Muntinlupa City" and recommend the approval by the City Mayor;

WHEREAS, pursuant to the **Supreme Court (SC)** decision, there is a need for the Sangguniang Panlungsod to *ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with AM-FM Builders for the project Street Lighting located at Main Road, Intercity Homes, Barangay Cupang, Muntinlupa City in the amount of Seven Hundred Eighty Thousand Five Hundred Fifty Two Pesos and 04/100 (Php780,552.04) which amount shall be taken from the 2012 Executive Budget Under 20% Community Development Fund (CDF).
