A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF ROAD CONSTRUCTION OF PLEASANT VILLAGE LOCATED AT PLEASANT VILLAGE, BAYANAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION TWENTY TWO THOUSAND SIX HUNDRED SEVENTY NINE PESOS AND 00/100 (PHP2,022,679.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2012 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, on July 2, 2012, the 6th Sangguniang Panlungsod approved **Ordinance No. 12-075**, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the Road Construction at Pleasant Village located at Pleasant Village, Bayanan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on August 9, 2012, the City Government of Muntinlupa entered into Construction Agreement with PDJ INTEGRATED CONSTRUCTION for the Road Construction at Pleasant Village amounting to Two Million Twenty Two Thousand Six Hundred Seventy Nine Pesos and 00/100 (Php2,022,679.00)

WHEREAS, on June 22, 2012, the Bids and Awards Committee (BAC) approved Resolution No. 12-0035, "declaring the PDJ INTEGRATED CONSTRUCTION as the bidder with the Lowest Calculated Responsive Bid for the Road Construction at Pleasant Village located at Pleasant Village, Bayanan, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the Supreme Court (SC) decision, there is a need for the Sangguniang Panlungsod to ratify contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with PDJ INTEGRATED CONSTRUCTION for the project construction of Road Construction at Pleasant Village located at Pleasant Village, Bayanan, Muntinlupa City in the amount of Two Million Twenty Two Thousand Six Hundred Seventy Nine Pesos and 00/100 (Php2,022,679.00) which amount shall be taken from the 2012 Executive Budget under 20% Community Development Fund (CDF).
