

RESOLUTION NO. 12-245

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AM-FM BUILDERS FOR THE PROJECT CONSTRUCTION OF ADDITIONAL NICHES LOCATED CITY CEMETERY, PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION FIVE THOUSAND EIGHT HUNDRED SIXTY TWO PESOS AND 47/100 (PHP2,005,862.47) WHICH AMOUNT SHALL BE TAKEN FROM THE 2012 EXECUTIVE BUDGET UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, on August 6, 2012, the 6th Sangguniang Panlungsod approved **Ordinance No. 12-089**, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the **Construction Of Additional Niches** located at Public Cemetery, Putatan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on August 14, 2012, the City Government of Muntinlupa entered into Construction Agreement with AM-FM BUILDERS for the Construction Of Additional Niches amounting to Two Million Five Thousand Eight Hundred Sixty Two Pesos And 47/100 (Php2,005,862.47) as a result of a public bidding held on **August 29, 2012**;

WHEREAS, on **August 31, 2012**, the Bids and Awards Committee (BAC) approved Resolution No. 12-008, "declaring the AM-FM BUILDERS as the bidder with the Lowest Calculated Responsive Bid for the Construction Of Additional Niches located at Public Cemetery, Putatan, Muntinlupa City and recommend the approval by the City Mayor;


