**WHEREAS**, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *"unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations". The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed"*;

**WHEREAS**, on December 26, 2012, Atty. Ethelwolda C. Aldea, OIC, City Personnel Office transmitted the re-appointment of Atty. Isidoro L. Soriano, Jr., as Temporary Department Head II (SG-26) with a permanent position at the Local Civil Registrar's Office;

**WHEREAS**, Atty. Isidoro L. Soriano, Jr., continued his work at the Muntinlupa City Government and became Legal Officer (1989 – 1997), Chief Arbitration & Mediation Law Office (1997-1998), Technical Assistant on Legal Affairs (1999-2001), Secretary to the Sangguniang Panlungsod (2001-2002) Graft Investigation Officer II (2002-2003) and Officer-In-Charge at the **Local Civil Registrar's Office** from July 1, 2008;

**WHEREAS**, on October 13, 2008, the 5<sup>th</sup> Sangguniang Panlungsod approved **Resolution No. 08-207**, concurred the appointment of Atty. Isidoro L. Soriano, Jr. as Department Head II (SG-26/1) with a Permanent Position at the **Local Civil Registrar's Office**;




