WHEREAS, in the letter dated August 15, 2013 of the Medical Director of the Hospitalng Muntinlupa, Dr. Edwin L. Dimatatac to Hon. City Mayor Atty. Jaime R. Fresnedi the World Medical Relief Inc., is going to donate hospital beds, side tables, equipment, instruments and other supplies for free;

WHEREAS, there are expenses in the shipment and other costs that should be paid by the City Government of Muntinlupa with a total amount of **One Million Six Hundred Ninety Two Thousand Five Hundred Pesos** (Php1,692,500.00), like -

1. **Ocean Freight US port to Philippines of the 40ft container van rental.**
2. **Inland Freight Michigan to New York**
3. **Documentary and FEDEX Fees covering authentication of documents from Philippine Consulate Office Chicago, Illinois**
4. **Professional Packers and Loading costs (US labor)**
5. **Local expenses for tax exemption clearance and documents from department of Finance, Manila LSPI**
6. **Terminal Logistics, legal fees, brokerage portorage and other miscellaneous handling fees**
7. **Inland freight (trucking) from port of Davao to Muntinlupa (exclusive from above mentioned fees)**

WHEREAS, the 40 footer container van will be fully loaded of the hospital beds, side tables, equipment, instruments and other supplies to be donated and according to the list requested by the Dr. Quimosing and Dr. Dimatatac of the Ospital ng Muntinlupa shall contain;

WHEREAS, the hospital beds, side tables, equipment, instruments and other supplies are going to be used in Geriatric Wing of the Ospital ng Muntinlupa;

WHEREAS, the acceptance of the donation is advantageous to the City Government despite of the shipment costs and other expenses amounting to **One Million Six Hundred Ninety Two Thousand Five Hundred Pesos (Php1,692,500.00)** than to buy similar hospital beds, side tables, equipment, instruments and other supplies according to Dr. Dimatatac;

WHEREAS, completing the hospital beds and side tables, equipment, instruments and other supplies in the Geriatric Wing, the City Government will spend an estimated amount of **Three Million Five Hundred Seventeen Thousand Four Hundred Fifty (Php3,517,450.00)**;

WHEREAS, there is a available fund from the 2013 Executive Budget under the subsidy special account of Ospital ng Muntinlupa of the **Maintenance and Other Operating Expenditures (MOOE)**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **7th Sangguniang Panlungsod of Muntinlupa** authorizing the **City Mayor Hon. Atty. Jaime R. Fresnedi** to represent and sign for and in behalf of the City Government to accept the donation of Medical Equipment and Supplies to be donated by the World Medical Relief Inc. and allocating the amount of **One Million Six Hundred Ninety Two Thousand Five Hundred Pesos (Php1,692,500.00)** for the shipment and other expenses.
