WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, ***“xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned”***;

WHEREAS, on October 3, 2013 the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa signed the Memoranda of Agreement (MOA) among the ***Department of Trade and Industry (DTI), Social Security System (SSS), Home Development Mutual Fund (PAG-Ibig) and Philippine Health Insurance Corporation (Philhealth)*** regarding Muntinlupa City's connectivity to the Philippine Business Registry.

WHEREAS, the City Government of Muntinlupa is committed to provide a highly favorable business friendly environment;

WHEREAS, in order to achieve this goal, there is an imperative need to improve the service delivery by streaming the business registration procedure in the city;

WHEREAS, the **Philippine Business Registry (PBR)** project is an inter-agency project that will facilitate business registration-related transactions by integrating all national agencies, Local Government Units (LGUs) and other permit/license-issuing agencies involved in business registration;

WHEREAS, a Memoranda of Agreement (MOA) shall be entered into by and among the City Government of Muntinlupa, **Department of Trade and Industry (DTI), Social Security System (SSS), Home Mutual Fund (Pag-IBIG) and the Philippine Health Insurance Corporation (PhilHealth)**, to provide for the terms and conditions as well as the duties and responsibilities of each party for the connectivity and operation of the Philippine Business Registry (PBR);

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the **7th Sangguniang Panlungsod**, to ratify the **Memoranda of Agreement (MOA)** entered into by the **City Mayor Hon. Atty. Jaime R. Fresnedi** in behalf of the City Government of Muntinlupa with the **Department of Trade and Industry (DTI), Social Security System (SSS), Home Development Mutual Fund (Pag-ibig) and Philippine Health Insurance Corporation (Philhealth)** regarding Muntinlupa City's connectivity to the Philippine Business Registry (PBR).
