A RESOLUTION DECLARING THE WHOLE VICTORIA HOMES SUBDIVISION AS AN OPEN AREA FOR THE INSTALLATION OF PIPED WATER SUPPLY BY MANILA WATERWORKS SEWERAGE SYSTEM (MWSS) AND ITS CONCESSIONAIRE MAYNILAD WATER SERVICES, INC., ON AN INDIVIDUAL HOUSE CONNECTION BASIS.

WHEREAS, Article 99, (5)(viii) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod, as the legislative body of the city shall enact ordinances which shall ensure the efficient and effective delivery of the basic services and facilities as provided in Rule V of these Rules, and in addition to said services and facilities shall:

(viii) regulate the drilling and excavation of the ground for the laying of water, xxx, and other pipes and the construction, repair and maintenance of public drains, sewers, cesspools, tunnels and similar structures;

WHEREAS, on December 15, 2011 the 6th Sangguniang Panlungsod approved Resolution No. 11-133 accepting the Deed of Donation of open roads, open spaces and electrical facilities located at Victoria Homes Subdivision, Barangay Tunasan, Muntinlupa City;

WHEREAS, one of the vision of the present administration is to ensure the Health of their constituents for giving clean, safe and uncontaminated supply of water;

WHEREAS, on November 26, 2013 the Committee on Engineering, Public Works and Infrastructure held a public hearing regarding the request of Engr. Hermes Dorado, President of Victoria Homes Village Association, seeking the adoption of a resolution declaring the whole Victoria Homes Subdivision as an open area for the provision of piped water supply by **Manila Waterworks Sewerage System (MWSS) and its concessionaire Maynilad Water Services, Inc.**, on an individual house connection basis;

WHEREAS, the eight (8) communities, also appear to the committee to declare their place and issue certificate as an open community so that they can avail the services of **Manila Waterworks Sewerage System (MWSS) and its concessionaire Maynilad Water Services, Inc.,;**

WHEREAS, the certificate of an open community is one of the requirements by the Maynilad to be submitted before they can start supplying water to the whole area of Victoria Homes Subdivision;

WHEREAS, the Homeowners communities of Victoria Homes Subdivision wish to have a safe and uncontaminated supply of water;

WHEREAS, the eight Homeowner communities President signed the letter request and submitted a certification that they are accepting the project and delivery of water services of **Manila Waterworks Sewerage System (MWSS) and its concessionaire Maynilad Water Services, Inc.,** to Victoria Homes Subdivision;

WHEREAS, the Homeowner communities of the Victoria Homes Subdivision (**Diamond Park, Emerald Park, Sapphire Hills, Jade Heights, Ridgeview I, Ridgeview 2 and Pearl Heights**) interposed no objection to said project of **Manila Waterworks Sewerage System (MWSS) and its concessionaire Maynilad Water Services, Inc.,;**

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7th Sangguniang Panlungsod of Muntinlupa, to declare the whole Victoria Homes Subdivision as an open area for the installation of piped water supply by **Manila Waterworks Sewerage System (MWSS) and its concessionaire Maynilad Water Services, Inc.,** on an individual house connection basis.




