A RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), TO TURN OVER TO THE CITY ALL THE TREES TAGGED TO BE CUT/UPROOTED/EARTH-BALLED ALONG RIZAL STREET AND INSULAR PRISON ROAD (KATIHAN ROAD), BARANGAY POBLACION, MUNTINLUPA CITY, AS A RESULT OF THE WIDENING BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO BE USED BY THE CITY GOVERNMENT OF MUNTINLUPA FOR ITS VARIOUS PROJECTS.

WHEREAS, on January 20, 2014, the Hon. City Mayor Atty. Jaime R. Fresnedi, wrote a letter requesting to the 7th Sangguniang Panlungod to pass and approve resolution asking the **Department of Environment and Natural Resources (DENR)**, to turn-over to the City all the trees tagged to be cut/uprooted/earth-balled along the **Rizal Street and Insular Prison Road (Katihan Road), Barangay Poblacion, Muntinlupa City**, as a result of the widening by the **Department of Public Works and Highways (DPWH)** to be used by the City Government of Muntinlupa for its various projects;

WHEREAS, Pursuant to the **Department of Environment and Natural Resources (DENR)** Guidelines and Procedures on the planting, maintenance and removal of trees in Urban areas and areas affected by the government infrastructure projects issued by the **Department of Environment and Natural Resources (DENR)** Secretary on November 27, 2009 and Executive Order No. 23, Series of 2011 and other pertinent government policies issued, a tree cutting and earth-balling permit is granted to **Department of Public Works and Highways (DPWH)**;

WHEREAS, the said trees are directly affecting and causing obstruction to the proposed road construction/widening project of road project along Rizal Street and Insular Prison Road (Katihan Road), Barangay Poblacion, Muntinlupa City;

WHEREAS, on December 3, 2012, the *Department of Public Works and Highways (DPWH)* wrote a letter requesting the *Department of Environment and Natural Resources (DENR)* permit to cut and earth-ball trees located at Rizal Street and along Insular Prison Road (Katihan Road), Barangay Poblacion, Muntinlupa City;

WHEREAS, the subject of request is ninety one (91) trees of various species of which: seventy (70) are forest trees of various species, thirteen (13) fruit bearing, four (4) ornamental plants or a total of eighty seven (87) trees and plants classified as non-premium species and four (4) forest trees of Narra and lanete species classified as premium species, a total of ninety (91) trees and plants;

WHEREAS, under DNF-UFD-C/BP# 2013-11-244 dated August 8, 2013, one of the conditions stated in the permit was to transplant and maintain the cut/uprooted/earth-balled trees to Marikina City for a period of three (3) years;

WHEREAS, it is the sentiment of the people of Muntinlupa that the cut/uprooted/earth-balled trees be utilized/planted in the city of origin to add to the beautification projects as well as to contribute to the ecological balance in Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7th *Sangguniang Panlungsod of Muntinlupa*, to request the *Department of Environment and Natural Resources (DENR)*, to turn-over to the City all the trees tagged to be cut/uprooted/earth-balled along the *Rizal Street and Insular Prison Road (Katihan Road), Barangay Poblacion, Muntinlupa City*, as a result of the widening project by the *Department of Public Works and Highways (DPWH)* to be used by the City Government of Muntinlupa for its various projects.

ADOPTED, by the 7th *Sangguniang Panlungsod of Muntinlupa* this 20th day of January 2014, on its 23rd *Regular Session*.
