#### ORDINANCE NO. 14-045

AN ORDINANCE AMENDING CERTAIN PROVISIONS IN ORDINANCE NO. 03-089, OTHERWISE KNOWN AS THE CHARTER OF PAMANTASANG NG LUNGSOD NG MUNTINLUPA.

WHEREAS, the Sangguniang Panlungsod of Muntinlupa approved Ordinance No. 03-089, entitled, "Charter Of Pamantasang Ng Lungsod Ng Muntinlupa";

WHEREAS, it has been more than ten years (10) since the charter of the Pamantasan ng Lungsod ng Muntinlupa was enacted Ordinance No. 03-089;

WHEREAS, it is imperative that the *Charter of Pamantasan ng Lungsod ng Muntinlupa* remains updated and at par with global development and progress;

WHEREAS, as recommended there is a need to amend certain provisions of *Ordinance No. 03-089* in order to reflect these development and progress;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED,** by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa in session assembled that:

**SECTION 1.** In *Article II Section I* is hereby amended by adding and inserting some provisions and shall now be read as follows:

- 1. The duly elected President of the Alumni Association of PLMUN as member;
- 2. The Regional Director of the Department of Science and Technology in the National Capital Region or such other like body as member;

**SECTION 2.** *Article II, Section 3* of Ordinance No. 03-089 also amended by adding the following members and *shall now be read as follows:*

- 1. The President concurrent with the term of the City Mayor;
- The duly elected President of the Alumnae Association of PLMUN as member – during his/her tenure as such President;
- 3. *The Regional Director of the Department of Science and Technology (DOST)* or such other like body-during his terms as such Director.

**SECTION 3.** *Article VI, Section I* on the powers and duties of the Board of Directors is hereby amended by adding another Section and powers and duties of Board of Regents and *shall now be read as follows*:

**Section 1.** Powers and Duties of the Board of Regents – Subject to the existing laws, the following are the powers and duties of the Board of Regents, in addition to the general administrative and corporate powers.

- 1. To approve, *upon the recommendation of the President of the Pamantasan ng Lungsod ng Muntinlupa,* the courses of study and rules of discipline drawn up by the University Council; to fix tuition fees, matriculation fees, graduation fees, and all special fees and charges;
- 2. To provide, *upon the recommendation of the President of the Pamantasan ng Lungsod ng Muntinlupa,* fellowship and scholarships and to award the same to students giving special evidence of merit.
- 3. **To confirm the** trusts, legacies, gifts, land grants, and donation of real and personal property of all kinds received by the President of the University and to determine the manner of the use thereof with due consideration to the conditions of the donor, if any, and the recommendation of the President.

SECTION 4, Article VI of Ordinance No. 03-089, is hereby amended by adding another Section, such *Powers and Duties* of the *President of the Pamantasan ng Lungsod ng Muntinlupa* and shall now be read as follows:

 To recommend to the Board of Regents, professors, instructors, lectures and other employees and their corresponding compensation, hours of service and such other duties and condition and to recommend the removal of employees for cause after due notice and investigation;



- To recommend to the Board of Regents the courses of study and rules of discipline drawn up by the University Council and the rates of tuition fees, matriculation fees, graduation fees, and all special fees and charges;
- 4) To recommend to the Board of Regents candidates for fellowships and scholarships;
- 5) To make a monthly report to the Chairman of the Board and/or to the Board of Regents on any matter within his knowledge, whether or not the same relates to the operation or administration of the University;
- 6) To preside in the Committee of Discipline and such, to actively participate in the resolution of grievances and complaints against any student or any university official, to have access to confidential information obtained during the investigation progress and to report the results thereof to the Chairman of the Board and/or the Board of Regents;
- To promulgate and enforce rules and discipline governing the officers, faculty, teaching, and nonteaching personnel;
- To coordinate and monitor the assigned tasks and program components of the different departments to ensure compliance and efficient operation of the University.
- 9) Upon confirmation of the Board of Regents, to receive in trust, legacies, gifts, land grants and donations of real and personal property of all kinds and to administer the same for the benefit of the university or for aid of any students in accordance with the direction of the donor and in such manner as the Board of Regents may its discretion determine;
- 10)To perform such other functions and duties as the Chairman of the Board or the Board of Regents may assign.

SECTION 5. Article VII, Section 1, on University Officials is hereby amended as and shall now be read as follows:

> 1. The President of the Pamantasan ng Lungsod ng Muntinlupa who shall be the Chief Executive of the PLMun. He/She shall be appointed by the Chairman with the concurrence of the Majority Vote of the Board of Regents. His Term is concurrent with the Chairman, unless sooner removed pursuant to Section 2 of this Article and/or for loss of confidence.

SECTION 2. Separability Clause - If for any reason or reasons any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 3. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 4. Effectivity Clause - This ordinance shall take effect upon approval.
