RESOLUTION NO. 14-049

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONTRACT WITH D.L CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT CONCRETE RETAINING WALL FENCE & ADDITIONAL LANDFILL (PACWOOD SITE) LOCATED AT PACWOOD, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF NINETEEN MILLION ONE HUNDRED TWENTY NINE THOUSAND SIX HUNDRED FORTY FOUR PESOS AND 70/100 (PHP19,129,644.70) WHICH AMOUNT SHALL BE TAKEN FROM THE 2013 EXECUTIVE BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF).

**WHEREAS**, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

**WHEREAS**, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

**WHEREAS**, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

**WHEREAS**, however, to further enhance transparency and accountability the Hon. City Mayor ATTY. JAIME R. FRESNEDI submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the **Construction Of Concrete Retaining Wall Fence & Additional Landfill (PACWOOD SITE)** at **PACWOOD, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) contractors submitted letters of intent and applications for eligibility, and one (1) was found eligible on December 19, 2013;

WHEREAS, two (2) were submitted on December 19, 2013 and bid passed the preliminary examination of bids;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **D.L. Cervantes Construction, Corporation** its bid has been found to be responsive to Approved Budget for the Contract (ABC);

WHEREAS, the amount appropriated for the said project shall be taken from the 2013 Executive Budget under 20% Community Development Fund (CDF);

WHEREAS, the approved budget for the project **Construction Of Concrete Retaining Wall Fence & Additional Landfill (PACWOOD SITE)** is **Nineteen Million One Hundred Twenty Nine Thousand, Six Hundred Forty Four and 70/100 (Php19,129,644.70)**;

WHEREAS, the project was awarded to **D.L. Cervantes Construction, Corporation**, who being the lowest bidder for the project, **Construction Of Concrete Retaining Wall Fence & Additional Landfill (PACWOOD SITE)** located at **PACWOOD, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Contract with **D.L Cervantes Construction Corporation** for the project **concrete retaining wall fence & additional landfill (Pacwood Site)** located at **Pacwood, Barangay Tunasan, Muntinlupa City** in the amount of **Nineteen Million One Hundred Twenty Nine Thousand, Six Hundred Forty Four and 70/100 (Php19,129,644.70)** which amount shall be taken from the **2013 Executive Budget Under the 20% Community Development Fund (CDF)**.


