A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONTRACT WITH PRISMODIAL CONSTRUCTION CORPORATION FOR THE PROJECT OF TWO STOREY MULTI-PURPOSE HALL LOCATED AT VILLA CAROLINA I, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION NINE HUNDRED FIFTY EIGHT THOUSAND SEVENTY FIVE PESOS AND 08/100 (PHP5,958,075.08) WHICH AMOUNT SHALL BE TAKEN FROM THE 2013 EXECUTIVE BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF).

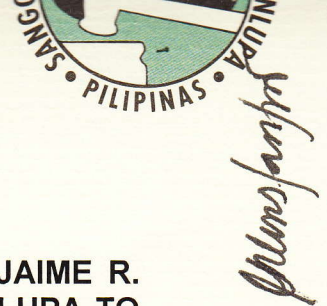
WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor **ATTY. JAIME R. FRESNEDI** submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the **Two Storey Multi Purpose Hall at Villa Carolina I, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) contractors submitted letters of intent and applications for eligibility, and one (1) was found eligible on December 3, 2013;

WHEREAS, two (2) were submitted on December 3, 2013 and bid passed the preliminary examination of bids;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, Prismodial Construction, its bid has been found to be responsive to Approved Budget for the Contract (ABC);

WHEREAS, the amount appropriated for the said project shall be taken from the 2013 Executive Budget under 20% Community Development Fund (CDF);

WHEREAS, the approved budget for the project Two Storey Multi Purpose Hall is **Five Million Nine Hundred Ninety Eight Thousand Five Hundred Eighteen Pesos and 13/100 (Php5,998,518.13)**;

WHEREAS, the project was awarded to **PRISMODIAL Construction**, who being the lowest bidder for the project **Two Storey Multi Purpose Hall** located at **Villa Carolina I, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Contract with **Prismodial Construction** for the project of **Two Storey Multi-Purpose Hall** located at **Villa Carolina I, Barangay Tunasan, Muntinlupa City** in the amount of **Five Million Nine Hundred Fifty Eight Thousand Seventy Five Pesos and 08/100 (Php5,958,075.08)** which amount shall be taken from the 2013 Executive Budget under the 20% Community Development Fund (CDF).
