FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH OPERATORS/OWNERS OF CINEMAS/THEATERS IN FILINVEST, STAR MALL, LLANAS MALL AND OTHER THEATERS/CINEMAS OWNERS/OPERATORS IN OTHER MALLS THAT WILL OPERATE IN THE FUTURE FOR THE GRANTING OF FREE ADMISSION TO MOVIE THEATER/HOUSE TO BENEFICIARIES OF THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA) OF MUNTINLUPA CITY.

**WHEREAS**, Section 455(b)(l)(vi) of Republic Act 7160 otherwise known as the Local Government Code of 1991, provides that xx the City Mayor shall exercise general supervision and control over all programs, projects, services and activities at the city government and in connection shall;

*(vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;*

**WHEREAS**, the City Government of Muntinlupa is dedicated to enhance the lives of Senior Citizens among its constituents through its Office of the Senior Citizens Affairs (OSCA);

**WHEREAS**, the Senior Citizens of Muntinlupa City are given preferential attention and priority to enjoy additional grant of incentive as an expression of gratitude to their invaluable contribution to the progress and prosperity of Muntinlupa City;

**WHEREAS**, allowing the Senior Citizens of Muntinlupa City to watch movies in theaters/cinema houses free of admission fee will give them enjoyment;

**WHEREAS**, watching movies is a form of relaxation and one of the ways of removing stress and worry;

**WHEREAS**, it is likewise acknowledged that removing stress/worries and relaxation are ways to delay the aging process of the Senior Citizens;

**WHEREAS**, the owner/operator of theater/cinema houses are considered partners of the City of Muntinlupa in helping the Senior Citizens;

**WHEREAS**, Muntinlupa and SM, in their desire to give additional privileges to qualified resident senior citizens of Muntinlupa, have agreed to absorb the remaining eighty (80%) or 100% of the Net of Senior Citizen discount of SM Cinemas Admission prices (net of the mandatory 20% discount as provided for in RA. 9994, and amusement tax) which would have otherwise been chargeable to such qualified resident Senior Citizens as follows: Muntinlupa 80% and SM 20%;

**WHEREAS**, Muntinlupa City shall waive the collection of the amusement taxes applicable to the movie admission tickets issued by the SM Cinema branch in SM Center Muntinlupa to qualified resident Senior Citizens of Muntinlupa;

**WHEREAS**, this agreement shall take effect upon its execution and shall automatically expire upon the lapse of three (3) years thereafter, unless otherwise terminated or amended by the parties in writing. This Agreement may be renewed subject to such terms and conditions as may be mutually agreed upon by the parties;

**WHEREAS**, the Terms of this Agreement shall apply only to Cinema Admission tickets issued by the SM Cinema branches located in SM Center Muntinlupa to qualified Senior Citizens who are bonafide residents of Muntinlupa as evidenced by the proper Office of Senior Citizens Affairs Identification Card duly issued by Muntinlupa (the beneficiaries) subject to the following conditions:

**WHEREAS**, the Beneficiaries may avail of this privilege only during **Mondays to Fridays**;

**WHEREAS**, the privilege shall not apply or be extended to companions of Beneficiaries who are not qualified resident senior citizens themselves;

**NOW, THEREFORE BE IT RESOLVED, AS IT HEREBY RESOLVED**, by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter for and in behalf of the City Government of Muntinlupa into a Memorandum of Agreement (MOA) with operators/owners of Cinemas/Theaters in Filinvest, Star Mall, Llanas Mall and other theaters/cinemas owners/operators in other Malls that will operate in the future for the granting of free admission to movie theater/house to beneficiaries of the Office of the Senior Citizens Affairs (OSCA) of Muntinlupa City.




