WHEREAS, both Article III, Section 8(d) of the City Charter of Muntinlupa (Republic Act 7926) and Section 454(d) of the (Republic Act 7160), otherwise known as the Local Government Code of 1991 provide that, "unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, the mandate of the Committee on Personnel Administration under Rule VIII (s) of the Internal Rules of Procedure for the 7th Sangguniang Panlungsod of Muntinlupa to confirm all appointments made by the Honorable City Mayor is derived from the above-mentioned provisions;

WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the appointment of Ms. WILHELMINA N. DELFIN as Department Head II at the Local Civil Registrar of the City Government of Muntinlupa and has submitted the same for the confirmation by the City Council;

WHEREAS, Mrs. WILHELMINA N. DELFIN, finished her Primary education at Tunasan Elementary School in 1966 and Secondary education at Muntinlupa National High School in 1970; graduated at Lyceum of the Philippines with the degree of Bachelor of Science in Office Management in 1973; Lacson College, with the degree of Bachelor of Science in Commerce in 1997; graduated at Laguna Northwestern College, Master in Business Administration (MBA) in 1998:
