WHEREAS, both Article III, Section 8(d) of the City Charter of Muntinlupa (Republic Act 7926) and Section 454(d) of the (Republic Act 7160), otherwise known as the Local Government Code of 1991 provide that, *“unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed”*;

WHEREAS, the mandate of the Committee on Personnel Administration under Rule VIII (s) of the Internal Rules of Procedure for the 7th Sangguniang Panlungsod of Muntinlupa to confirm all appointments made by the Honorable City Mayor is derived from the above-mentioned provisions;

WHEREAS, on 16th day of August, 2013, the 7th Sangguniang Panlungsod of Muntinlupa approved Ordinance No. 13-017, entitled, *“A Resolution Confirming The Appointment Of Mrs. Lualhati S. Morales As City Department Head II (Sg-26) At The Mayor’s Office Proper Of The City Government Of Muntinlupa.”*;

WHEREAS, *Mrs. Lualhati S. Morales*, joined the government service on April 1, 2002 and served up to June 15, 2007 as City Accountant, Finance Officer from April 2006 to June 2007, OIC-Assessor's Office from April 15, 2005 to December 31, 2006, Acting Assistant Department Head-Budget Office From August 2, 2001 to March 30, 2002, Information Technology Officer I-Accounting Department September 2, 1997 to July 31, 2000, Senior Accounting Specialist, Department of Budget and Management (DBM), Malacañang Manila from May 16, 1983 to September 1, 1997, Audit Examiner II, Commission on Audit (COA) Quezon City from October 1, 1982 to May 15, 1983;

WHEREAS, based on the above service record, *Mrs. Lualhati Morales* has met the minimum requirements of five years managerial experience as City Department Head;




