WHEREAS, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *"unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations". The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed*;

WHEREAS, The Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the appointment of Atty. Genalyn Calixto-Estrera as Department Head II at the Office of the City Mayor-Propor of the City Government of Muntinlupa and has submitted the same for the confirmation by the City Council;

WHEREAS, Atty. Genalyn Calixto-Estrera, finished her Primary education at St. Rita College in 1982 and Secondary education at St. Rita College in 1986, graduated at University of the Philippines School of Economics (Diliman) with the degree of Bachelor of Science in Economics in 1990 and Ateneo De Manila University School of Law the Degree of Juris Doctor of Law in 1998;

WHEREAS, Atty. Genalyn Calixto-Estrera, passed the BAR Examination, which is equivalent for a Career Civil Service Professional with a grade of 77.00%;
