WHEREAS, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, "unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations". The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, The Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the appointment of Atty. Genalyn Calixto-Estrera as Department Head II at the Office of the City Mayor-Proper of the City Government of Muntinlupa and has submitted the same for the confirmation by the City Council;
