## **RESOLUTION NO. 14-162**

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO CONSTRUCTION AGREEMENT ENTER INTO Α WITH TRISAN CONSTRUCTION & DEVELOPMENT FOR THE PROJECT CARES ACCESS ROAD LOCATED AT CAMELLA HOMES II & II-D BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF FOUR MILLION FIVE HUNDRED SEVENTY NINE THOUSAND FOUR HUNDRED THIRTY EIGHT PESOS AND 50/100 (Php4,579,438.50) WHICH AMOUNT SHALL BE TAKEN FROM THE 2014 EXECUTIVE BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the 7<sup>TH</sup> Sangguniang Panupased the Construction Agreement:

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the proposed project CARES Access Road at Camella II & II-D, Barangay Putatan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) contractor submitted letters of intent and application for eligibility, was found eligible on October 16, 2014;

WHEREAS, one (1) Bidder who submitted their Bid on October 16, 2014 and bid passed the Preliminary Examination of Bid at the *City Administrator Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City*:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, Trisan Construction & Development, its bid has been found to be responsive to *Approved Budget for the Contract (ABC)* amounting to Four Million Six Hundred Fifteen Thousand, Three Hundred Ninety-Three Pesos and 01/100 (Php4,615,393.01);

WHEREAS, the amount of *Four Million Five Hundred Seventy Nine Thousand Four Hundred Thirty Eight Pesos 50/100* (Php4,579,438.50) shall be taken from the 2014 Executive Budget under the 20% Community Development Fund (CDF);

**WHEREAS,** the *Approved Budget* for the project CARES access road is Four Million Six Hundred Fifteen Thousand, Three Hundred Ninety Three Pesos and 01/100 (Php4,615,393.01);

WHEREAS, the project was awarded to Trisan Construction & Development, who being the lowest and lone bidder for the project CARES access road located at Camella II & II-D, Barangay Putatan, Muntinlupa City;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED,** by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Trisan Construction & Development for the project CARES access road located at Camella Homes II & II-D Barangay Putatan, Muntinlupa City in the amount of Four Million Five Hundred Seventy Nine Thousand Four Hundred Thirty Eight Pesos and 50/100 (Php4,579,438.50) which amount shall be taken from the 2014 Executive Budget under the 20% Community Development Fund (CDF).
