A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH ELPA CONSTRUCTION FOR THE PROJECT ROAD CONCRETING AT BOLIVAR STREET, VILLA CAROLINA SUBDIVISION, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION SIX HUNDRED FIFTY FIVE THOUSAND TWENTY PESOS (Php2,655,020.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2014 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "*xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others*";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "*any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "*saw no need to seek authority from the City Council prior to entering into a contract*";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the 7TH Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid the project Road Concreting located at Bolivar Street, Villa Carolina Subdivision, Barangay Tunasan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) bidder/contractor submitted letter of intent and application for eligibility and was found eligible on December 02, 2014;

WHEREAS, one (1) Bidder who submitted their Bid on December 02, 2014 and bid passed the Preliminary Examination of Bid at the *City Administrator Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City*:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the lone bidder with lowest calculated bid, ELPA Construction its bid has been found to be responsive to *Approved Budget for the Contract (ABC) amounting to Two Million Six Hundred Fifty Seven Thousand One Hundred Twenty One Pesos and 26/100 (Php2,657,121.26)*;

WHEREAS, the amount of Two Million Six Hundred Fifty Five Thousand Twenty Pesos (Php2,655,020.00) shall be taken from the 2014 Executive Budget under the 20% Community Development Fund (CDF);

WHEREAS, the *Approved Budget* for the project **Road Concreting** is *Two Million Six Hundred Fifty Seven Thousand One Hundred Twenty One Pesos and 26/100 (Php2,657,121.26)*;

WHEREAS, the project was awarded to **ELPA Construction**, who being the lone bidder for the project **Road Concreting** located at Bolivar Street, Villa Carolina Subdivision, Barangay Tunasan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **7TH Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **ELPA Construction** for the project road concreting at **Bolivar Street, Villa Carolina Subdivision, Barangay Tunasan, Muntinlupa City** in the amount of **Two Million Six Hundred Fifty Five Thousand Twenty Pesos (Php2,655,020.00)** which amount shall be taken from the 2014 Executive Budget Under 20% Community Development Fund (CDF).
