WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

**WHEREAS,** pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the 7<sup>TH</sup> Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the repair and renovation of Cupang Health Center located at Barangay Cupang, Muntinlupa City, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, bidder/contractor submitted letter of intent and application for eligibility and was found eligible on December 22, 2014;

WHEREAS, one (1) Bidder who submitted their Bid on December 22 2014 and bid passed the Preliminary Examination of Bid at the City Administrato Conference Room. 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, Lordcons Builders its bid has been found to be responsive to Approved Budget for the Contract (ABC) amounting to Two Million Six Hundred Ninety Four Thousand Eight Hundred Fifty Six and 17/100 (Php2,694,856.17);

WHEREAS, the amount of Two Million Six Hundred Twenty Six Thousand Five Hundred Eleven Pesos and 03/100 ((Php2,626,511.03) shall be taken from the Department of Health (DOH) financial assistance;

WHEREAS, the project was awarded to Lordcons Builders, who being the lone bidder for the project repair and renovation of Cupang Health Center of located at Barangay Cupang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Lordcons Builders for the project repair and renovation of Cupang Health Center located at Barangay Cupang, Muntinlupa City in the amount of Two Million Six Hundred Twenty Six Thousand Five Hundred Eleven and 03/100 (Php2,626,511.03) which amount shall be taken from the Department of Health (DOH) financial assistance.
