A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH LORDCONS BUILDERS FOR THE PROJECT CONSTRUCTION OF PEDRO E. DIAZ HIGH SCHOOL ADMIN BUILDING LOCATED AT BARANGAY BAYANAN, MUNTINLUPA CITY IN THE AMOUNT OF ELEVEN MILLION FOUR HUNDRED FORTY-TWO THOUSAND NINE HUNDRED EIGHTY SEVEN PESOS AND 21/100 (Php11,442,987.21) WHICH AMOUNT SHALL BE TAKEN FROM THE 2014 SUPPLEMENTAL BUDGET-SCHOOL BOARD FUND UNDER CAPITAL OUTLAY.

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the 7TH Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid on December 1, 2014 for the construction of Pedro E. Diaz High School Admin Building located at Barangay Bayanan, Muntinlupa City, in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

in response to the said advertisements, one (1)WHEREAS, bidder/contractor submitted letter of intent and application for eligibility and was found eligible on December 17, 2014;

WHEREAS, one (1) Bidder who submitted their Bid on December 17 2014 and bid passed the Preliminary Examination of Bid at the City Administrator Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, Lordcons Builders its bid has been found to be responsive to Approved Budget for the Contract (ABC) amounting to Eleven Million Four Hundred Forty-Nine Thousand Seven Hundred Ninety Nine Pesos and 07/100 (Php11,499,799.07);

WHEREAS, the amount of Eleven Million Four Hundred Forty-Two Thousand Nine Hundred Eighty Seven Pesos and 21/100 (Php11,442,987.21) shall be taken from the 2014 Supplemental Budget-School Board Fund under the Capital Outlay;

WHEREAS, the project was awarded to Lordcons Builders, who being the lone bidder for the project construction of Pedro E. Diaz High School Admin Building located at Barangay Bayanan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Lordcons Builders for the project Construction of Pedro E. Diaz High School Admin Building located at Barangay Bayanan, Muntinlupa City in the amount of Eleven Million Four Hundred Forty-Two Thousand Nine Hundred Eighty Seven Pesos and 21/100 (Php11,442.987.21) which amount shall be taken from the 2014 Supplemental Budget-School Board Fund under Capital Outlay.




