FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND LINGKOD MUNTINLUPA FOUNDATION FOR THE IMPLEMENTATION OF A CARE CARD PROJECT WHEREIN MEDICAL OR HEALTH BENEFITS OFFERED BY THE CITY TO ITS CONSTITUENTS SHALL BE MADE CARD-BASED.

WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, provides that, ***“every local government unit created or recognized under this Code is a body politic and corporate endowed with the powers to be exercised by it in conformity with law”***;

WHEREAS, Section 22 of the same Code states that, “every Local Government Unit, as a corporation, shall have the following powers:

- 1) ***To have continuous succession in its corporate name;***
- 2) ***To sue and be sued;***
- 3) ***To have and use a corporate seal;***
- 4) ***To acquire and convey real or personal property;***
- 5) ***To enter into a contracts;***
- 6) ***To exercise such other powers as are granted to corporate, subject to the limitation provided in this Code and other laws;***

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "**xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned**";

WHEREAS, the City Government of Muntinlupa will enter into a **Memorandum of Agreement (MOA)** with **Lingkod Muntinlupa Foundation, Inc.**, for the implementation of a **Card System Program** wherein medical or health benefits offered by the City to its constituents shall be made **Card-Based System**;

WHEREAS, the subject of the **Memorandum of Agreement (MOA)** is the **Muntinlupa Care Card Project** which seeks to supply, implement and maintain a smart card system to Muntinlupa residents;

WHEREAS, the said **Care Card** can avail on a voluntary basis by those who will pay a fee of **Eighty Pesos (Php80.00)** per card, inclusive of VAT for initial registration and **Twenty Pesos (Php20.00)** for annual renewal subject for the approval of the Sangguniang Panlungsod, and the **Care Card** is valid for one (1) year;

WHEREAS, the MOA contained the following aims to wit:

- a. To provide card-based benefits systems that will accurately store and protect member information;
- b. To supply a dependable medical transaction tracking system with full traceability and reports;
- c. Deliver a card solution that has the ability to integrate with other existing programs to add to the total value of the card;
- d. Include benefits scheme that can support multiple levels and types of rewards that can be based on member profiles, demographics and memberships levels;
- e. Provide free ride for its members within the designated route if its electronic jeepneys (e-JRF).

WHEREAS, the members of the Care Card will enjoy the following benefits:

- i. Free use of electronic jeepney (e-JRF);
- ii. Discounts movie tickets at partner establishments;
- iii. Discounts medical purchase on partner drugstores;
- iv. Discounts on selected retail outlets
- v. Accident Insurance (for 18 to 65 years old)
- vi. In addition, the members can easily avail of the benefits offered by the City Government by integrating these benefits in the Muntinlupa Care Card Project.

WHEREAS, the Contract shall be for a period of **ten (10) years**, counted from effective date, renewable for another term upon mutual agreement of the parties;

WHEREAS, the City Government shall approve the designated route and stops of the e-JRF and shall provide the necessary facilities in the approved routes, including the command center of the e-JRF;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi** to enter into and sign in behalf of the City Government of Muntinlupa a **Memorandum of Agreement (MOA)** between the **City Government of Muntinlupa** and **Lingkod Muntinlupa Foundation, Inc.**, for the implementation of a **Care Card Project** wherein **Medical or Health Benefits** offered to its constituents shall be made **Card-Based**.
