A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH E.M. ANGELES FOR THE PROJECT CONSTRUCTION OF DRAINAGE SYSTEM (MAIN ROAD) LOCATED AT SUMMITVILLE SUBDIVISION, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED NINETY FOUR THOUSAND SEVEN HUNDRED THIRTY SIX PESOS (Php1,894,736.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the 7TH Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the Construction Of Drainage System (Main Road) located at Summitville Subdivision, Barangay Putatan, Muntinlupa City, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, bidder/contractor submitted letter of intent and application for eligibility and was found eligible on February 26, 2015;

WHEREAS, two (2) Bidders who submitted their Bid on February 26, 2015 and bid passed the Preliminary Examination of Bid at the City Administrator Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, E.M. Angeles Enterprises its bid has been found to be responsive to Approved Budget for the Contract (ABC) amounting to One Million Nine Hundred Twenty Four Thousand One Hundred Thirty Nine Pesos and 54/100 (Php1,924,139.54);

WHEREAS, the amount of One Million Eight Hundred Ninety Four Thousand Seven Hundred Thirty Six Pesos (Php1,894,736.00) shall be taken from the 2015 Executive Budget under 20% Community Development Fund (CDF);

WHEREAS, the project was awarded to E.M. Angeles Enterprises, who being the winning bidder for the project construction of drainage system (main road) located at Summitville Subdivision, Barangay Putatan, Muntinlupa City;

WHEREAS, on March 06, 2015 the Bids and Awards Committee (BAC) approved Resolution No. 2015-Infra 008 declaring E.M. Angeles Enterprises as the bidder with the Lowest Calculated and Responsive Bid for the project construction of drainage system (main road) located at Summitville Subdivision, Barangay Putantan, Muntinlupa City;
