A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KME DESIGN & CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE PAVILION PHASE 1 & 2, LOCATED AT MUTUAL HOMES SUBDIVISION, SOLDIERS' HILLS VILLAGE, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF SIX MILLION ONE HUNDRED TWENTY THREE THOUSAND THREE PESOS AND 90/100 (Php6,123,003.90) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECT (NON-OFFICE).

**WHEREAS**, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

**WHEREAS**, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

**WHEREAS**, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

**WHEREAS**, however, to further enhance transparency and accountability the **Hon. City Mayor Atty. Jaime R. Fresnedi** submitted to the 7<sup>TH</sup> Sangguniang Panlungsod the Construction Agreement;

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the Construction Of Multi-Purpose Pavilion Phase 1 & 2, located at Mutual Homes Subdivision, Soldiers' Hills Village, Barangay Putatan, Muntinlupa City, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisements, one (1) bidder/contractor submitted letter of intent and application for eligibility and was found eligible on February 5, 2015;

**WHEREAS**, one (1) Bidder who submitted their Bid on February 5, 2015 and bid passed the Preliminary Examination of Bid at the *City Administrator Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City*;

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **KME Design & Construction** its bid has been found to be responsive to *Approved Budget for the Contract (ABC) amounting to Six Million Three Hundred Eleven Thousand Four Hundred Fifty Eight Pesos and 80/100 (Php6,311,458.80)*;

**WHEREAS**, the amount of Six Million One Hundred Twenty Three Thousand Three Pesos And 90/100 (**Php6,123,003.90**) shall be taken from the 2015 Executive Budget under Infrastructure Project (Non-Office);

**WHEREAS**, the project was awarded to **KME Design & Construction**, who being the lone bidder for the project **construction of Multi-Purpose Pavilion (Phase 1 & 2)** located at Mutual Homes Subdivision, Soldiers Hills Village, Barangay Putatan, Muntinlupa City;

**WHEREAS**, on February 16, 2015 the Bids and Awards Committee approved Resolution No. 2015-Infra 002 declaring KME Design & Construction as the bidder with the Lowest Calculated and Responsive Bid for the project construction of Multi-Purpose Pavilion, Phase 1 & 2, located at Mutual Homes Subdivision, Soldiers Hills Village, Barangay Putatan, Muntinlupa City;




