A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH LEADTEK CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE PAVILLION LOCATED AT VILLA CAROLINA 2, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF SIX MILLION THREE HUNDRED FIFTY-NINE THOUSAND THREE HUNDRED PESOS (Php6,359,300.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER CAPITAL OUTLAY-INFRASTRUCTURE PROJECTS.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the 7TH Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the amount of Six Million Three Hundred Fifty-Nine Thousand Three Hundred Pesos (Php6,359,300.00) shall be taken from the 2015 Executive Budget under Capital Outlay-Infrastructure Project;

WHEREAS, the project was awarded to **LEADTEK CONSTRUCTION**, who being the winning bidder for the project **Construction Of Multi-Purpose Pavillion** located at **Villa Carolina 2, Barangay Tunasan, Muntinlupa City**;
