#### **RESOLUTION NO. 15-219**

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH P.B. GREY CONSTRUCTION FOR THE PROJECT ROAD CONCRETING (FROM PNR TO STO. NIÑO VILLAGE ENTRANCE) LOCATED AT STO. NIÑO VILLAGE, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF EIGHT MILLION EIGHT HUNDRED FORTY THOUSAND PESOS (Php8,840,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER CAPITAL OUTLAY-INFRASTRUCTURE PROJECTS.

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the 7<sup>TH</sup> Sangguniang Panlungsod the Construction Agreement;

GREY CONSTRUCTION its bid has been found to be responsive to Approved Budget for the Contract (ABC) amounting to Eight Million, Eight Hundred Forty Six Thousand, Sixty Pesos and 84/100 (Php8,846,060.84);

WHEREAS, the amount of Eight Million Eight Hundred Forty Thousand Pesos (Php8,840,000.00) shall be taken from the 2015 Executive Budget under Capital Outlay-Infrastructure Project;
