A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH E.M. ANGELES ENTERPRISES FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE COVERED COURT LOCATED AT GAWAD KALINGA-MRH, SOLDIER'S HILLS VILLAGE, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF EIGHT MILLION SEVEN HUNDRED SIXTY FOUR, EIGHT HUNDRED EIGHTY THOUSAND PESOS (Php8,764,880.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER CAPITAL OUTLAY-INFRASTRUCTURE PROJECTS.

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "*any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "*saw no need to seek authority from the City Council prior to entering into a contract*";

WHEREAS, however, to further enhance transparency and accountability the ~~Hon. City Mayor Atty. Jaime R. Fresnedi~~ submitted to the 7TH Sangguniang Panlungsod the Construction Agreement;

WHEREAS, in response to the said advertisements, two (2) bidders/contractors submitted letter of intent and application for eligibility and was found eligible on March 10, 2015;

WHEREAS, two (2) Bidders who submitted their Bid on March 10, 2015 and bid passed the Preliminary Examination of Bid at the *City Administrator Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City*;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **E.M. Angeles Enterprises** its bid has been found to be responsive to *Approved Budget for the Contract (ABC) amounting to Eight Million, Seven Hundred Eighty Four, Eight Hundred Eighty Five and 58/100 (Php8,784,885.58)*;

WHEREAS, the amount of **Eight Million Seven Hundred Sixty Four Thousand Eight Hundred Eighty Pesos (Php8,764,880.00)** shall be taken from the 2015 Executive Budget under Capital Outlay-Infrastructure Project;

WHEREAS, the project was awarded to **E.M. Angeles Enterprises**, who being the winning bidder for the project **construction of Multi-Purpose Covered Court** located at Gawad Kalinga-MRH, Soldier's Hills Subdivision, Barangay Putatan, Muntinlupa City;
