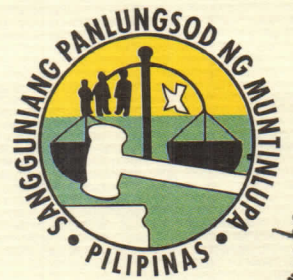

RESOLUTION NO. 15-232

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH DL CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF MUNTINLUPA RESILIENCY CENTER LOCATED AT NATIONAL ROAD, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF SEVENTY TWO MILLION EIGHT HUNDRED FIFTY THOUSAND FIVE HUNDRED NINETY FOUR PESOS AND 89/100 (PHP72,850,594.89) WHICH AMOUNT SHALL BE TAKEN FROM THE 2014 CONTINUING APPROPRIATION - 2015 EXECUTIVE BUDGET UNDER THE INFRASTRUCTURE PROJECT - CAPITAL OUTLAY (CO).

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panglungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the *Construction Of Muntinlupa Resiliency Center Located At National Road, Barangay Tunasan, Muntinlupa City* in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) contractor submitted letter of intent and application for eligibility, and one (1) was found eligible on March 19, 2015;

WHEREAS, one (1) bidder was submitted on March 19, 2015 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, *D.L Cervantes Construction Corporation* its bid has been found responsive to **Approved Budget for the Contract (ABC)**;

WHEREAS, the amount appropriated for the said project shall be taken from the 2014 Executive Budget under 2015 Continuing Appropriations (CA) – Infrastructure Project – Capital Outlay;

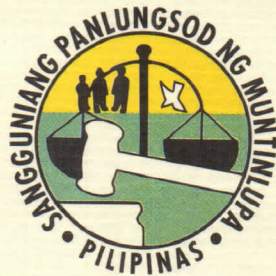
WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of Riprap and Perimeter Fence is *Seventy Three Million Eighty Three Thousand, Seven Hundred Seventy Seven Pesos and 53/100 (Php73,083,777.53)*;

WHEREAS, the project was awarded to *D.L Cervantes Construction Corporation*, who being the lone and lowest bidder for the project, *Construction Of Muntinlupa Resiliency Center Located At National Road, Barangay Tunasan, Muntinlupa City*;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **D.L. Cervantes Construction Corporation** for the project *Construction Of Muntinlupa Resiliency Center Located at National Road, Barangay Tunasan, Muntinlupa City* in the amount of *Seventy Two Million Eight Hundred fifty Thousand, Five Hundred Ninety Four Pesos and 89/100 (Php72,850,594.89)* which amount shall be taken from the 2014 Continuing Appropriation - 2015 Executive Budget under the 20% Infrastructure Project – Capital Outlay (CO).
