#### **RESOLUTION NO. 15-236**

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH HCM CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF BAYANAN HEALTH CENTER (PHASE 2) LOCATED AT BAYWALK, BARANGAY BAYANAN, MUNTINLUPA CITY IN THE AMOUNT OF TWELVE MILLION NINE HUNDRED FORTY-TWO THOUSAND SEVENTY TWO PESOS AND 50/100 (PHP12,942,072.50) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF) INFRASTRUCTURE PROJECT-CAPITAL OUTLAY (CO).

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bidé and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlypa advertised the Invitation to Apply for Eligibility and to Bid of the project Construction of Bayana Health Center (Phase 2) located at Bayanan Baywalk, Barangay Bayanan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two contractor/bidders submitted letter of intent and application for eligibility, and one (1) was found eligible on May 14, 2015;

WHEREAS, two (2) bidders was submitted on May 14s, 2015 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, HCM CONSTRUCTION CORPORATION its bid has been found responsive to Approved Budget for the Contract (ABC);

WHEREAS, the amount appropriated for the said project shall be taken from the 2015 Executive Budget 20% Community Development Fund (CDF) under Infrastructure Project-Capital Outlay;

WHEREAS, the Approved Budget for the Contract (ABC) for the project construction of Bayanan Health Center (Phase 2) is Twelve Million Nine Hundred Eighty Two Thousand Three Hundred Nine Pesos and 22/100 (Php12,982,309.22);

WHEREAS, the project was awarded to HCM CONSTRUCTION CORPORATION who being the lowest bidder for the project, Construction of Bayana Health Center (Phase 2) located at Baywalk, Barangay Bayanan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with HCM CONSTRUCTION CORPORATION for the project Construction of Bayanan Health Center (Phase 2) located at Baywalk, Barangay Bayanan, Muntinlupa City in the amount of Twelve Million Nine Hundred Forty-Two Thousand Seventy Two Pesos and 50/100 (Php12,942,072.50) which amount shall be taken from the 2015 Executive Budget under the 20% Community Development Fund (CDF) Infrastructure Project-Capital Outlay (CO).
