WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, provides that, "every local government unit created or recognized under this Code is a body politic and corporate endowed with the powers to be exercised by it in conformity with law";

WHEREAS, Section 22 of the same Code states that, "every Local Government Unit, as a corporation, shall have the following powers:

- 1) To have continuous succession in its corporate name;
- To sue and be sued;
- 3) To have and use a corporate seal;
- 4) To acquire and convey real or personal property;
- To enter into a contracts;
- 6) To exercise such other powers as are granted to corporate, subject to the limitation provided in this Code and other laws;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances'

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the Local Planning and Development Office (LPDO) acts as the coordinating body and the center of operations of all committees, bodied, etc., that form the development council and the operations of the council itself either directly or through its executive committee led by the Local Chief Executive;

WHEREAS, the Community Based Monitoring System Network Team led by Dr. Celia Reyes, is the research group that develop the CBMS Network, with support from the International Development Research Center (IDRC-Canada) is a coordinating body under the partnership for Economic Policy Research Network for the development and implementation of community based and local poverty monitoring systems in developing countries;

WHEREAS, the Department of Interior Local Government (DILG) through the Bureau of Local Government Development is the office primary responsible for the implementation of the Millennium Development Goals (MDG) localization and for the capacity building, of local government units on poverty diagnosis and planning using CBMS and its institutionalization at the local level:

WHEREAS, the Community Based Monitoring System (CBMS) national repository which is intended to be used as inputs for policy making and program implementation has been established and being maintained at DILG and NAPC with technical support from the CBMS Network Team;

WHEREAS, the City Government of Muntinlupa through its City Planning and Development Office requests for technical assistance from the CBMS Network Team in cooperation with the DILG-BLGD on the institutionalization of the community based monitoring system as a planning and monitoring tool at the city and barangay levels in Muntinlupa;

WHEREAS, the City Council approved Ordinance No. 15-127 for this purpose;

WHEREAS, the Terms and Conditions setforth under the approved Memorandum of Agreement (MOA) shall be form part of this Resoluton;

WHEREAS, there is an available fund from the 2015 Executive Budget;
