A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH TRISAN CONSTRUCTION & DEVELOPMENT FOR THE PROJECT CONSTRUCTION OF CAREGIVER COURSE ROOM AND COOKERY COURSE WORKSTATION LOCATED AT MUNTINLUPA CITY TECHNICAL INSTITUTE (MCTI) SAN GUILLERMO, BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION SIX HUNDRED TWENTY SIX THOUSAND SEVEN HUNDRED TWENTY TWO PESOS AND 76/100 (Php1,626,722.76) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 UNDER APPROPRIATION BUDGET CONTINUING EXECUTIVE INFRASTRUCTURE PROJECT - CAPITAL OUTLAY (CO).

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the project Construction of Caregiver Course Room And Cookery Course Workstation located at Muntinlupa City Technical Institute (Mcti) San Guillermo, Barangay Putatan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted letter of intent and application for eligibility, and one (1) was found eligible on May 12, 2015:

WHEREAS, two (2) bidders was submitted on May 12, 2015 and the bid passed the Preliminary Examination;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, *Trisan Construction & Development* its bid has been found responsive to *Approved Budget for the Contract (ABC)*;

WHEREAS, the amount appropriated for the said project shall be taken from the 2015 Executive Budget Continuing Appropriation under Infrastructure Project-Capital Outlay;

WHEREAS, the Approved Budget for the Contract (ABC) for the project construction of Caregiver Course Room And Cookery Course Workstation is One Million Six Hundred Twenty Nine Thousand Twenty Four Pesos and 66/100 (Php1,629,024.66);

WHEREAS, the project was awarded to Trisan Construction & Development who being the lowest bidder for the project, Construction of Caregiver Course Room And Cookery Course Workstation located at Baywalk, Barangay Bayanan, Muntinlupa City;
