A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH PRIJOLES TRADING CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE COVERED COURT LOCATED AT DOÑA ROSARIO HEIGHTS, BARANGAY SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF EIGHT MILLION SEVEN HUNDRED SIXTY TWO THOUSAND FIVE HUNDRED SEVENTY TWO PESOS AND 09/100 (Php8,762,572.09) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER THE GENERAL FUND.

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, in response to the said advertisement, one (1) bidder submitted letter of intent and application for eligibility, was found eligible on March 10, 2015;

WHEREAS, one (1) Bidder who submitted their Bid on March 10, 2015 and bid passed the Preliminary Examination of Bid at the City Administrator Conference Room 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the lone bidder with lowest calculated bid, Prijoles Trading & Construction its bid has been found to be responsive to Approved Budget for the Contract (ABC) amounting to Eight Million Seven Hundred Ninety Thousand, Eighty Seven Pesos and 17/100 (Php8,790,087.17);

WHEREAS, the amount of Eight Million Seven Hundred Sixty Two Thousand Five Hundred Seventy Two Pesos and 09/100 (Php8,762,572.09) Which Amount Shall Be Taken From The 2015 Executive Budget under the General Fund;

WHEREAS, the Approved Budget for the project construction of Multi-Purpose Covered Court is Eight Million Seven Hundred Ninety Thousand, Eighty Seven Pesos and 17/100 (Php8, 790, 087.17);

WHEREAS, the project was awarded to Prijoles Trading & Construction, by virtue of BAC Resolution No. 2015-Infra 016 who being the lowest and lone bidder for the project Multi-Purpose Covered Court located at Doña Rosario Subdivision, Barangay Sucat, Muntinlupa City,

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Prijoles Trading & Construction for the project construction of Multi-Purpose Covered Court located at Doña Rosario Subdivision, Barangay Sucat, Mantinlupa City in the amount of Eight Million Seven Hundred Sixty Two Thousand Five Hundred Seventy Two Pesos And 09/100 (Php8,762,572.09) which amount shall be taken from the 2015 Executive Budget under the General Fund.
