**WHEREAS**, it is the policy of the state to recognize and strengthen the capacities of LGU's and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

**WHEREAS**, Section 458 in relation to Section 16 of Local Government Code, empowers Sanggunian Panlungsod as the legislative body of the city, shall enact ordinances and adopt resolutions for the general welfare of the city and its inhabitants xxx";

- (iv) **Adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood, following the said events;**

**WHEREAS**, while it is the objective of the City Government of Muntinlupa to prepare for the protection of their constituents, there is a need to rehabilitate all drainage within the City of Muntinlupa;

**WHEREAS**, towards this end the City Government of Muntinlupa respectfully request the Hon. Representative of the Lone District of Muntinlupa City Congressman Rodolfo G. Biazon to integade with the DPWH for the rehabilitation of drainage system along M.L. Quezon Avenue from Barangay Tunasan to Barangay Sucat;

**WHEREAS**, it is common knowledge that during rainy season the usual areas affected by the natural occurrence are those within the low areas;

**WHEREAS**, the said drainage system of the barangays along ML Quezon Road, serves as the main interceptor/tributaries of household waste water;

**NOW, THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED**, by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to request the Department of Public Works and Highways (DPWH), thru our Honorable Representative of the Lone District of Muntinlupa City, Congressman Rodolfo Biazon, for rehabilitation and decloged of drainage system along M.L. Quezon Avenue from Barangay Sucat to Barangay Tunasan within the jurisdiction of MuntinlupaCity.

**RESOLVED FURTHER**, that a copy of this resolution be immediately furnished the Honorable Department of Public Works and Highways (DPWH) and the Honorable Representative Rodolfo Biazon for their appropriate action.
