WHEREAS, on *October 5, 2015*, the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa passed a Resolution Number 15-265, requesting the South Luzon Tollways Corporation to take immediate action on the defective/damaged posts along the Alabang Viaduct Area;

WHEREAS, said resolution was passed due to the observed breaking of steel jackets on the concrete posts along the Alabang Viaduct;

WHEREAS, upon verbal coordination of the City Engineer's office with the SLTC, the latter claimed that the breaking of steel jackets was due to the additional load and impact load of the top of the viaduct;

WHEREAS, the additional and impact load will have a corresponding effect on the structural stability hence there is a need to determine whether the corrective measures such as the repair of the steel jackets as reinforcement of the concrete posts is sufficient and effective deterrent to the possible movement of the posts;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to request the South Luzon Tollways Corporation (SLTC) to issue a Certificate of Structural Soundness of the Alabang Viaduct.

RESOLVED FURTHER, that copies of this resolution be furnished the Department of Public Works and Highway (DPWH) and the Metro Manila Development Authority (MMDA).

ADOPTED, by the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 5<sup>th</sup> day of October 2015, on its 98<sup>th</sup> Regular Session.
