WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the Comprehensive Health Program has been one of the top priority-eight-point programs of the City Government of Muntinlupa;

WHEREAS, Philippine Charity Sweepstake Office (PCSO) is the principal government agency tasked to raise and provide financial assistance program to the partner healthcare provider such as Ospital ng Muntinlupa;

WHEREAS, pursuant to Philippine Charity Sweepstake Office (PCSO) Board Resolution No. 236 series of 2015 and as an act of liberality and generosity of Philippine Charity Sweepstake Office (PCSO), approved an Endowment Fund of 2015 in favor of Ospital ng Muntinlupa in the amount of Two Million Pesos (Php2,000,000.00) payable in one release, subject to the availability of funds and applicable accounting and auditing rules and regulations;

WHEREAS, the use of the funds is subject to General Policies and Specific Guidelines provided for by the Philippine Charity Sweepstake Office (PCSO);

WHEREAS, the aforesaid endowment fund will tremendously benefit the indigent patient of Ospital ng Muntinlupa without monetary counter part of the City;

NOW, THEREFORE BE IT RESOLVE, AS IT IS HEREBY RESOLVED, by the 7th Sangguniang Panlungsod ng Muntinlupa, to authorize the Hon. City Mayor, Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MAO) with the Philippine Charity Sweepstakes Office (PCSO) accepting the Two Million Pesos (Php2,000,000.00) endowment fund as Medical Assistance Program for and in behalf of the indigent patients of the Ospital ng Muntinlupa.

RESOLVED FURTHER, that copies of this resolution be furnish the Philippine Charity Sweepstakes Office (PCSO) and the Ospital ng Muntinlupa for their information.
