A RESOLUTION ADOPTING MUNICIPALITIES OF JAEN AND LUPAO, **ASSISTANCE** TO THEIR **ECIJA** TO GIVE INFRASTRUCTURE AND AGRICULTURE DUE TO THE EFFECT BROUGHT BY TYPHOON LANDO WHICH CAUSE MASSIVE FLOODING IN THE SAID PROVINCES AND THAT THE CITY MAY DECIDE TO HELP AND SUPPORT WHICH AMOUNT SHALL BE TAKEN FROM THE MUNTINLUPA CITY RISK REDUCTION MANAGEMENT FUND (MCRRDMF).

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 (An Act amending Section 324(d) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, "a portion of Calamity Fund may be authorized to be used by the LGU concerned to provide financial assistance to other LGUS",

WHEREAS, on October 21, 2015 the Metro Manila Council (MMC), composed of 17 Mayors in the National Capital Region (NCR), passed Resolution adopting the local government units that were badly damaged by typhoon LANDO and will be adopted in terms of assistance to their infrastructure and agriculture;

WHEREAS, under MMC Resolution it will be up to the sponsoring Metro Manila Local Government Units to implement programs or mechanism including technical and engineering experts with local government expertise to facilitate the recovery of its adopted localities;

WHEREAS, there were eighteen (18) municipalities affected by Typhoon Lando which caused massive flooding in the Province of Nueva Ecija, Bulacan, Pampanga and Zambales which overwhelmed the functional integrity of their infrastructure and damaged to their agriculture;

WHEREAS, the Municipalities of JAEN and LUPAO in the Province of Nueva Ecija are the local government units which was affected by the typhoon and were chosen to be adopted by the City Government of Muntinlupa;

WHEREAS, adopting the Municipalities of JAEN and LUPAO will entail post damage assessment need analysis in order to itemize the fund allocation to be given for the immediate rehab and recovery of these Municipalities;

WHEREAS, post damage assessment and active assistance will take a year in order to evaluate in full the damage to live and properties;

WHEREAS, there is an available fund from the Muntinlupa City Risk Reduction Management Fund (MCRRDMF);

NOW THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED, by the 7th Sangguniang Panlungsod of Muntinlupa, to adopt Municipalities of Jaen and Lupao, Nueva Ecija to give assistance to their damaged infrastructure and Agriculture due to the effect brought by Typhoon Lando which cause massive flooding in the said provinces and that the City may decide to help and support which amount shall be taken from the Muntinlupa City Risk Reduction Management Fund (MCRRMF).
