WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, provides that, "**every local government unit created or recognized under this Code is a body politic and corporate endowed with the powers to be exercised by it in conformity with law**";

WHEREAS, Section 22 of the same Code states that, "**every Local Government Unit, as a corporation, shall have the following powers:**

- 1) **To have continuous succession in its corporate name;**
- 2) **To sue and be sued;**
- 3) **To have and use a corporate seal;**
- 4) **To acquire and convey real or personal property;**
- 5) **To enter into a contracts;**
- 6) **To exercise such other powers as are granted to corporate, subject to the limitation provided in this Code and other laws;**

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "**the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

**WHEREAS**, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "**xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned**";

**WHEREAS**, the Philippine Charity Sweepstakes Office is the principal government agency for raising and providing funds for health programs, medical assistance, and services, and charities of national character;

**WHEREAS**, one of the charity programs of Philippine Charity Sweepstakes Office (PCSO) is the Individual Medical Assistance Program (IMAP) where medical assistance is given through the issuance of Guarantee Letters (GL) to partner hospitals and the PCSO assumes the obligation of setting the cost of medicines, chemo drugs, dialysis solutions, and other medical needs of said patients with said hospitals;

**WHEREAS**, to maximize the limited resources of PCSO vis-à-vis the number of indigent patients that have to be assisted estimated at 400 patients a day, the PCSO seeks to establish a partnership through the PCSO Desk, otherwise known as the "**At Source and Processing**" (ASAP) service delivery system, with various private and government hospitals which are willing to assist the agency in the implementation of the IMAP, by providing not only medical and health-related services but also medicines for chemotherapy, hemodialysis and post operative treatment, to patients referred by PCSO including the putting up of a PCSO Desk within their premises, to handle and evaluate requests for financial assistance from their own patients;

**WHEREAS**, Pursuant to BR No. 228, series of 2015 (Annex A), the PCSO approved PCSO's partnership with thirteen (13) government hospitals, which includes Partner Health Facility (PHF), as partner agencies in the implementation of the IMAP through the PCSO Desk/A service delivery system;

**WHEREAS**, in cognizant of the noble objective of this project, the Partner Health Facility (PHF) which under this case, is the Ospital ng Muntinlupa, signified its willingness to support the Philippine Charity Sweepstakes Office (PCSO) and be its partner in the implementation of the Individual Medical Assistance Program (IMAP);

**WHEREAS**, patients who will avail themselves of the assistance from PCSO under this agreement, shall still be entitled to other discounts allowed under the existing laws, including the Senior Citizen's Discount and Persons with Disability Discount.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the <sup>7<sup>th</sup></sup> Sangguniang Panlungsod of Muntinlupa, to authorize **Hon. City Atty. Mayor Jaime R. Fresnedi** to enter into and sign in behalf of the City Government of Muntinlupa a Memorandum Of Agreement (MOA) with the **Philippine Charity Sweepstakes Office (PCSO)** for the program "**At Source And Processing (ASAP)**" desk service delivery system at Ospital ng Muntinlupa (OSMUN).
