VALENCIA, MD.,MPH, CESO III-DIRECTOR IV FOR THE GRANT OF FUND FOR MEDICAL EQUIPMENT ACQUISITION UNDER THE HEALTH FACILITY ENHANCEMENT PROGRAM.

WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, provides that, ***“every local government unit created or recognized under this Code is a body politic and corporate endowed with the powers to be exercised by it in conformity with law”***;

WHEREAS, Section 22 of the same Code states that, ***“every Local Government Unit, as a corporation, shall have the following powers:***

- 1) ***To have continuous succession in its corporate name;***
- 2) ***To sue and be sued;***
- 3) ***To have and use a corporate seal;***
- 4) ***To acquire and convey real or personal property;***
- 5) ***To enter into a contracts;***
- 6) ***To exercise such other powers as are granted to corporate, subject to the limitation provided in this Code and other laws;***

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "**xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned**";

WHEREAS, the Department of Health (DOH) issued Guidelines on the implementation of the Health Facility Enhancement Program (HFEP) for CY-2014 to cover the Health Facilities Enhancement Program, projects to Regional Offices for allocation to the different Local Government Unit (LGU) facilities;

WHEREAS, under the Millenium Development Goal the following shall be implemented in compliance with the Philippine's commitment to health by the Year 2015:

1. **The construction, upgrading, expansion, repair and rehabilitation of DOH retained hospital and the other health facilities, such as Rural Health Units (RHUs) district/provincial hospitals and barangay health stations;**
2. **Purchase of medical equipment;**

WHEREAS, the Local Government of Muntinlupa City is one of the identified recipient of the procurement of medical equipments;

WHEREAS, the General Appropriations Act (GAA) for the Fiscal Year 2014 allocated the amount of **Five Hundred Eighty Two Billion, Five Hundred Eighteen Million Pesos (Php582,518,000,000.00)** to the Department of Health – National Capital Region Office under the Health Facilities Enhancement Program for the facilities of Local Government Units and other health sector partners;

WHEREAS, on **April 14, 2014** the Department of Health (DOH) issued Department Order No. 2014-0071 wherein the amount of **Sixteen Million Eight Hundred Thousand Pesos (Php16,800,000.00)** is allocated to **Muntinlupa City** for the purchase of medical equipment;

WHEREAS, the funds released shall be valid for obligation until December 31, 2015 and the Department of Health-National Capital Region Office (DOH-NCRO) shall transfer the funds to the Local Government of Muntinlupa City;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi** to enter into and sign in behalf of the City Government of Muntinlupa a **Memorandum Of Agreement (MOA)** with the **Department of Health-National Capital Region Office (DOH-NCRO)** represented by **Ariel L. Valencia, MD, MPH, CESO III-Director IV** for the grant of fund for medical equipment acquisition under the **Health Facility Enhancement Program (HFEP)**.

**RESOLVED FURTHER**, that the Memorandum of Agreement (MOA) shall be form an integral part of this Resolution;
