A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH FRAMECON BUILDERS FOR THE PROJECT CONSTRUCTION MULTI-PURPOSE COVERED COURT LOCATED AT PLEASANT VILLAGE, BARANGAY BAYANAN, MUNTINLUPA CITY IN THE AMOUNT OF EIGHT MILLION SEVEN HUNDRED NINETY NINE THOUSAND ONE HUNDRED SEVENTY-THREE PESOS AND 47/100 (PHP8,799,173.47) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "*xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others*";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "*any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "*saw no need to seek authority from the City Council prior to entering into a contract*";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panglungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Construction Multi-Purpose Covered Court located at Pleasant Village, Barangay Bayanan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said posting, sealed proposal was submitted to the BAC on or before the deadline last September 8, 2015;

WHEREAS, the sealed proposal was received and forwarded by the BAC to the Technical Working Group (TWG) for its evaluation and recommendation;

WHEREAS, the BAC receive a favorable recommendation from the TWG for the award of the contract to FRAMECON BUILDERS a supplier/contractor of known technical, legal and financial competence at negotiated price of **Eight Million Seven Hundred Ninety Eight Thousand Thirty Two Pesos and 79/100 (Php8,798,032.79)**;

WHEREAS, the amount appropriated for the said project shall be taken from the 2015 Executive Budget;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of **Construction Multi-Purpose Covered Court** is **(Php8,799,173.47)**;

WHEREAS, the project was awarded to **Framecon Builders** who being the responsive bidder for the project **Construction Multi-Purpose Covered Court located at Pleasant Village, Barangay Putatan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Sibalom Glass And Aluminum Construction Supply And Services For The Project Road Concreting And Drainage Construction Located At Ampaya-Emilla Compound, Barangay Putatan, Muntinlupa City In The Amount Of Three Million Five Hundred Twelve Thousand Three Hundred Thirty Eight Pesos And 41/100 (Php3,512,338.41) Which Amount Shall Be Taken From The 2015 Executive Budget.

ADOPTED, by the 7th **Sangguniang Panlungsod of Muntinlupa** this 2nd day of **November 2015**, on its 102nd Regular Session.
