A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, provides that, "**every local government unit created or recognized under this Code is a body politic and corporate endowed with the powers to be exercised by it in conformity with law**";

WHEREAS, Section 22 of the same Code states that, "every Local Government Unit, as a corporation, shall have the following powers: xxx, "**to exercise such other powers as are granted to corporate, subject to the limitation provided in this Code and other laws**;"

WHEREAS, the 7th Sangguniang Panlungsod approved **Resolution No. 15-258**, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi**, to enter into a **Memorandum of Agreement (MOA)** with the **Department of Interior and Local Government Regional Director** in connection with the release of the **2015 Performance Challenge Fund amounting to Five Million (Php5,000,000.00)** awarded to the City of Muntinlupa for passing the **Seal of Good Local Governance (SGLG)**;

WHEREAS, the use of the PCF for the construction of the 2 storey day care center located at Laguerta, Barangay Tunasan, Muntinlupa City is in accordance with the guidelines provided in the Memorandum of Agreement (MOA) particularly as to the attainment of the millennium development goals in the field of education;
