WHEREAS, Section 22 of the same Code states that, "every Local Government Unit, as a corporation, shall have the following powers: xxx, "to exercise such other powers as are granted to corporate, subject to the limitation provided in this Code and other laws;"

WHEREAS, the 7th Sangguniang Panlungsod approved Resolution No. 15-258, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi, to enter into a Memorandum of Agreement (MOA) with the Department of Interior and Local Government Regional Director in connection with the release of the 2015 Performance Challenge Fund amounting to Five Million (Php5,000,000.00) awarded to the City of Muntinlupa for passing the Seal of Good Local Governance (SGLG);

WHEREAS, the use of the PCF for the constrution of the 2 storey day care center located at Laguerta, Barangay Tunasan, Muntinlupa City is in accordance with the guidelines provided in the Memorandum of Agreement (MOA) particularly as to the attainment of the millennium development goals in the field of education;
