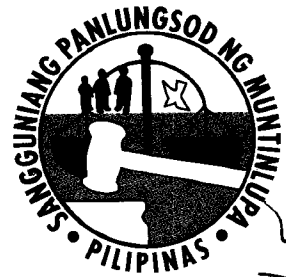

RESOLUTION NO. 15-298

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH MCCD ENGINEERING SERVICES & TRADING FOR THE PROJECT CONSTRUCTION INSTALLATION OF AIRCONDITIONING AND REHABILITATION OF FLOORING AND BENCHES LOCATED AT MUNTINLUPA SPORTS COMPLEX, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF THIRTY FOUR MILLION, NINE HUNDRED FIFTY-TWO THOUSAND FOUR HUNDRED FORTY PESOS (PHP34,952,440.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 SUPPLEMENTAL BUDGET UNDER UNAPPROPRIATED SURPLUS-AVAILABLE RETAINED EARNINGS-GENERAL FUNDS.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "**any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly**";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "**saw no need to seek authority from the City Council prior to entering into a contract**";

WHEREAS, however, *to further enhance transparency and accountability* the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the Sangguniang Panlungsod the **Construction Agreement**;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project Construction Installation Of Airconditioning And Rehabilitation Of Flooring And Benches *located at Muntinlupa Sports Complex, Barangay Tunasan, Muntinlupa City* in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) contractor/bidder submitted letter of intent and application for eligibility, and one (1) was found eligible on October 08, 2015;

WHEREAS, one (1) bidder was submitted on October 08, 2015 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **MCCD Engineering Services & Trading** its bid proposal has been found to be responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the 2015 Supplemental Budget Under Unappropriated Surplus-Available Retained Earnings-General Funds;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of Construction Installation Of Airconditioning And Rehabilitation Of Flooring And Benches is **(Php35,066,874.90)**;

WHEREAS, the project was awarded to **MCCD Engineering Services & Trading** who being the responsive bidder for the project, Construction Installation Of Airconditioning And Rehabilitation Of Flooring And Benches *located at Muntinlupa Sports Complex, Barangay Tunasan, Muntinlupa City*;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. Fresnedi*, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with *MCCD Engineering Services & Trading* For The Project Construction Installation Of Airconditioning And Rehabilitation Of Flooring And Benches Located At Muntinlupa Sports Complex, Barangay Tunasan, Muntinlupa City In The Amount Of *Thirty Four Million, Nine Hundred Fifty-Two Thousand Four Hundred Forty Pesos (Php34,952,440.00)* Which Amount Shall Be Taken From The 2015 Supplemental Budget Under Unappropriated Surplus-Available Retained Earnings-General Funds.


