RESOLUTION NO. 15-303

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH R2A CONSTRUCTION & TRADING FOR THE PROJECT CONSTRUCTION MUNTINLUPA CITY BOUNDARY LANDMARKS LOCATED AT VARIOUS BOUNDARIES (PARAÑAQUE CITY, LAS PIÑAS, TAGUIG, CAVITE, LAGUNA & ALABANG) OF MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION SIX HUNDRED THIRTEEN THOUSAND EIGHT HUNDRED SIX PESOS AND 12/100 (PHP1,613,806.12) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECT- CAPITAL OUTLAY.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

**WHEREAS**, however, *to further enhance transparency and accountability* the **Hon. City Mayor Atty. Jaime R. Fresnedi** submitted to the Sangguniang Panlungsod the **Construction Agreement**,

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project construction of Muntinlupa City Boundary Landmarks *located at various boundaries of (Parañaque City, Taguig, Las Piñas, Cavite, Laguna & Alabang)*, **Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisements, two (2) contractors/bidders submitted letter of intent and application for eligibility, and one (1) was found eligible on November 5, 2015;

**WHEREAS**, one (1) bidder was submitted on November 5, 2015 and bid passed the preliminary examination of bid;

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **R2A Construction & Trading** its bid proposal has been found to be responsive;

**WHEREAS**, the amount appropriated for the said project shall be taken from the 2015 Executive Budget under Infrastructure Project-Capital Outlay;

**WHEREAS**, the **Approved Budget for the Contract (ABC)** for the project construction of Muntinlupa City Boundary Landmarks is (**Php1,620871.84**);

**WHEREAS**, the project was awarded to **R2A Construction & Trading** who being the responsive bidder for the project, construction of Muntinlupa City Boundary Landmarks *located at various boundaries of (Parañaque City, Las Piñas, Taguig, Cavite, Laguna & Alabang)*, Muntinlupa City;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **R2A Construction & Trading** for the project construction of **Muntinlupa City Boundary Landmarks located at Various Boundaries (Parañaque City, Las Piñas, Taguig, Cavite, Laguna & Alabang), of Muntinlupa City** in the amount of **One Million Six Hundred Thirteen Thousand Eight Hundred Six Pesos and 12/100 (Php1,613,806.12)** which amount shall be taken from the ~~2015 Executive Budget Under Infrastructure Project-Capital Outlay~~.




