the Local Government Code of 1991 provide that, "unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed":

WHEREAS, one of the mandates of the Committee on Personnel Administration under Rule VIII (s) of the Internal Rules of Procedure for the 8th Sangguniang Panlungsod of Muntinlupa is to recommend the confirmation of all appointments made by the City Mayor to the City Council:

WHEREAS, Engr. Allan A. Cachuela was previously confirmed by the 7th Sangguniang Panlungsod as City Department Head II, (City Administrator) of the City Government of Muntinlupa by virtue of Resolution No. 13-002;

WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the re-appointment of Engr. Allan A. Cachuela as City Administrator of Muntinlupa by the City Council in compliance with CSC Resolution No. 001156 where the administrator is considered co-terminus and highly confidential in nature:

WHEREAS, the Charter of the City of Muntinlupa provides in Article VIII thereof the list of appointive officials of the City, their qualifications, powers and duties;

WHEREAS, in particular, Section 36 of the Charter provides that:

"Section 36. The City Administrator – The City Administrator must be a citizen of the Philippines, a resident of the City of Muntinlupa, of good moral character, holding a college degree preferably in public administration, law, or any related course from a recognized college or university, and a first grade civil service eligible or its equivalent. He must have acquired experience in management and administration work for at least five (5) years immediately preceding the date of his appointment xxx."

WHEREAS, Engr. Allan A. Cachuela, finished his Primary education at Tunasan Elementary School in 1981 and Secondary education at Sacred Heart Institute Muntinlupa City in 1985. He graduated at University of the East Manila with the degree of Bachelor of Science in Civil Engineer in 1990, and took Masters in Business Management at Saint Francis of Assisi College at Las Piñas City in 1999;

WHEREAS, Engr. Allan A. Cachuela, also passed the following examinations: Jr. Geodetic Engineering Board Exam with the rate of 70%, Senior Police Officer Examination 74.99%, Police Office I Examination 84.76 and Career Civil Service Professional, 83.33%;

WHEREAS, Engr. Allan A. Cachuela, joined the government service in 1992 as Planning Officer up to 1998, and City Zoning Administrator in June 1998 up to June 30, 2007 and became the City Administrator on July 1, 2013 up to June 30, 2016;

WHEREAS, Engr. Allan A. Cachuela, attended various seminars, skills trainings, workshops sponsored both by the Government and Private Institutions that can be used as his aid and tool for his public service work;

WHEREAS, there is a need for the *confirmation of re-appointment* of *Engr. Allan A. Cachuela*, to legally discharge his duties, functions, and responsibilities as City Administrator of the City Government of Muntinlupa;

NOW, THEREFORE BE IT RESOLVE, AS IT IS HEREBY RESOLVED, by the 7th Sangguniang Panlungsod of Muntinlupa to confirm the re-appointment of *Engr. Allan A. Cachuela* as City Administrator of the City Government of Muntinlupa.

RESOLVED, FURTHER, that a copy of this resolution be furnished the Personnel Office, the Office of the Mayor and the Civil Service Commission (CSC).
