A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH M2 BUILDERS CORPORATION FOR THE PROJECT ROAD ASPHALTING LOCATED AT SAINT ROSE, SAINT MARY AND SAINT ANDREW STREETS, JPA SUBDIVISION, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF THREE MILLION FOUR HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED SIXTY THREE PESOS AND 06/100 (PHP3,458,463.06) WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET UNDER THE INFRASTRUCTURE PROJECT - CAPITAL OUTLAY.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, “xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others”;

WHEREAS, pursuant to Section 76 of RA. 9184 states that, “any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly”;

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, “saw no need to seek authority from the City Council prior to entering into a contract”;

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the **Road Asphalting** located at **Saint Rose, Saint Mary and Saint Andrew Streets, JPA Subdivision, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) contractors submitted letter of intent and application for eligibility, and one (1) was found eligible on February 16, 2016;

WHEREAS, one (1) were submitted on February 16, 2016 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **M2 Builders Corporation** its bid has been found to be responsive to Approved Budget for the Contract (ABC);

WHEREAS, the amount appropriated for the said project shall be taken from the 2016 Executive Budget under Infrastructure Project-Capital Outlay;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project **drainage system** is **Three Million Four Hundred Sixty Five Thousand Five Hundred Eighty Two Pesos ad 56/100 (Php3,465,582.56)**;

WHEREAS, the project was awarded to **M2 Builders Corporation**, who being the lone and lowest bidder for the project road asphaltting located at **Saint Rose, Saint Mary and Saint Andrew Streets, JPA Subdivision, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, RESOLVE, AS IT IS HEREBY RESOLVED, by the **8th Sangguniang Panlungsod**, to authorize the City Mayor **Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **M2 Builders Corporation** for the project road asphaltting located at **Saint Rose, Saint Mary and Saint Andrew Streets, JPA Subdivision, Barangay Tunasan, Muntinlupa City** in the amount of **Three Million Four Hundred Fifty Eight Thousand Four Hundred Sixty Three Pesos and 06/100 (Php3,458,463.06)** which amount shall be taken from the 2016 Executive Budget under the Infrastructure Project - Capital Outlay.
