A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA A TRIPARTITE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DepEd)—MUNTINLUPA AND NATIONAL WATER RESOURCE BOARD (NWRB).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the public hearing concerned the authority to be given to the Hon. City Mayor Jaime R. Fresnedi to enter into a tripartite Memorandum of Agreement with the National Water Resource Board (NWRB) and the Department of Education (DepEd) Muntinlupa;

WHEREAS, the NWRB under Article 3(d) of the Water Code of the Philippines (PD1067) has been granted powers to regulate the exploitation, development, conservation, and protection of the country's water resources;

WHEREAS, one of the major functions of NWRB is the regulation of the country's water resources, including assessment and management of water supply and demand as basis for systematic allocation, control, management and development of available water resources for various functional uses;

WHEREAS, the NWRB undertakes the project Development of Groundwater Management Plan for Highly Urbanized Water Constraint Cities in Metro Manila and Cavite areas, that considers future impact of climate change and provide a framework and decision support tools using science based methology, to effectively manage groundwater resources;

WHEREAS, National Water Resource Board (NWRB) requested the Local Government of Muntinlupa City and DepEd Muntinlupa City to allow NWRB the use of a portion of lot in the identified selected campuses in Muntinlupa City for the construction of two (2) groundwater monitoring wells and the request was granted for further study;

WHEREAS, National Water Resource Board (NWRB) together with the representative from our Planning Office following the instructions from our City Administrator, had an ocular inspection of the identified sites for the construction of two (2) groundwater monitoring wells in Muntinlupa and these are the following: Alabang Elementary School and Muntinlupa National High School (MNHS);

WHEREAS, the Local Government of Muntinlupa will not allocate any fund for this project because the National Water Resource Board (NWRB) will shoulder the expenses for its construction;

WHEREAS, the *Ground Water Management Plan*, the *Memorandum of Agreement* (MOA) and the *Specs of the said monitoring wells* shall form part of this Resolution for the city's information's and record;

WHEREAS, the terms and conditions of the MOA are the following:

a) The obligations of National Water Resource Board:

- Construct two (2) ground water monitoring wells located in the selected campus and secure the necessary permit to drill for use as a monitoring well for two (2) months duration within the period of July 2016 to February 2017;
- Orient, inform and capacitate the DepEd-Muntinlupa City and LGU-Muntinlupa City on data collection;
- Inspect and collect data from the monitoring well at least twice a year or as necessary;
- ➤ Encode collected water quality and water level data and provide the LGU-Muntinlupa City and DepEd-Muntinlupa City all groundwater data gathered within the study area which can be used by LGU-Muntinlupa City Planning staff and the students for research and other purposes;

Educate the students and the LGU concerned staff on the protection of groundwater sources and the effects of overextraction of groundwater on the environments.

b) The obligations of DepEd Muntinlupa:

- Upon prior condition with the LGU and NWRB, Collect groundwater level and water quality data in the groundwater monitoring wells within the campus, on such agreed times as may be deemed necessary;
- Protect the groundwater monitoring wells from vandalism and such other similar acts that would caused damage to the well;
- Not appropriate groundwater from said deepwell, for any purpose;

c) The obligations of Local Government of Muntinlupa City are the following:

- Allow the construction of the two (2) groundwater monitoring located at the School campuses;
- ➤ Provide upon compliance with requirements, the necessary local permits for construction of the two (2) groundwater monitoring wells;
- Assist in the monitoring and protecting the wells from vandalism;

NOW THEREFORE, RESOLVE, AS IT IS HEREBY RESOLVED, by the 8th Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter into and sign in behalf of the City Government of Muntinlupa a Tripartite Memorandum of Agreement (MOA) with the Department of Education (Deped)–Muntinlupa and National Water Resource Board (NWRB).

ADOPTED, by the 8th Sangguniang Panlungsod of Muntinlupa this 1st day of August, 2016, on its 4th Regular Session.
