WHEREAS, both Article III, Section 8(d) of the City Charter of Muntinlupa (Republic Act 7926) and Section 454(d) of the (Republic Act 7160), otherwise known as the Local Government Code of 1991 provide that, *“unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed”*;

WHEREAS, the mandate of the Committee on Personnel Administration under Rule VIII (s) of the Internal Rules of Procedure for the 7th Sangguniang Panlungsod of Muntinlupa to confirm all appointments made by the Honorable City Mayor is derived from Article III, Section 8(d) of Republic Act 7926, otherwise known as the “City Charter of Muntinlupa” which provides as follows:

“Unless otherwise provided herein, all appointed city officials of the City shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod Members, subject to Civil Service Law, Rules and Regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed.”

WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, as the appointing authority, has recommended the re-appointment of Atty. Harley L. Padolina as Local Civil Registry Office of Muntinlupa and has submitted the same for the confirmation by the City Council on **August 1, 2016**;

WHEREAS, on 17th day of **August 2014**, **Atty. Harley L. Padolina** was confirmed by the **7th Sangguniang Panlungsod** as City Department Head II, of the Local Civil Registry Office of the City Government of Muntinlupa by virtue of **Resolution No. 15-254**;

WHEREAS, the status of appointment of Atty. Harley L. Padolina is **Temporary** due to lack of experience relevant to the position as City Local Civil Registrar;

WHEREAS, Section 479, Article IX of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, "**he must have acquired experience in civil registry work for at least five (5) years in the case of the city civil registrar**"; *[Handwritten signature]*

WHEREAS, Atty. Harley Lopena Padolina, Jr., finished his Primary education at Sucat Elementary School in 1970 and Secondary education at Muntinlupa National High School in 1974, graduated at Lyceum of the Philippines with the degree of Bachelor of Science in psychology in 1979 and Lyceum of the Philippines of Bachelor of Law the Degree of Juris Doctor of Law in 1987;

WHEREAS, Atty. Harley Lopena Padolina, Jr., joined the government service on January 1, 1990 up to December 31, 1993 as Legal Researcher; January 1, 1995 up to September 25, 1997 as Legal Officer IV; September 26, 1997 to August 1, 1999 as Legislative Staff Officer VI at the City Government of Muntinlupa; August 2, 1999 up to August 1, 2006 as Public Attorney II at PAO-RIV Binangonan District; and **August 1, 2013 up to Present** as Technical Assistant at Local Civil Registry Office (LCRO) of the City Government of Muntinlupa;

WHEREAS, Atty. Harley Lopena Padolina, Jr., attended various seminars, skills trainings, workshops sponsored both by the Government and Private Institutions that can be used as his aid and tool for his public service work;

WHEREAS, there is a need for the confirmation of appointment of Atty. Harley Lopena Padolina, Jr., to legally discharge his duties, functions, and responsibilities as Department Head II at the Local Civil Registry Office (LCRO) of the City Government of Muntinlupa;

WHEREAS, based on the documents submitted and verifications made during the public hearing, Atty. Harley Lopena Padolina, Jr., is qualified for the appointment and position as City Government Department Head II at the Local Civil Registry Office (LCRO) of the City Government of Muntinlupa;
